NEXT, BGCD IMPROVED ITS TECHNOLOGY TO BEGIN VIRTUALLY SERVING CLUB MEMBERS. BGCD EVEN EQUIPPED THREE BUSES WITH WI-FI BROADCASTING CAPABILITIES THAT ARE DEPLOYED TO DENSELY POPULATED APARTMENT BUILDINGS TO PROVIDE MEMBERS WITH THE HIGH-SPEED INTERNET THEY NEED TO SUCCEED IN THE MODERN ACADEMIC ENVIRONMENT.

TO KEEP CLUB SUPPORTERS AND STAFF SAFE, BGCD MODIFIED ITS ANNUAL TOPPS CELEBRATION BANQUET TO BE A VIRTUAL EVENT. BGCD MADE SIMILAR SAFETY CHANGES TO MOST OF ITS REGULARLY SCHEDULED FUNDRAISING EVENTS. WHILE THESE EVENTS WERE SUCCESSFUL AND SAFE, REVENUE WAS LOWER THAN A TYPICAL YEAR WHERE THE EVENTS ARE IN PERSON. FINALLY, BGCD ALSO REDUCED CAPACITIES FOR ITS AFTERSCHOOL AND SUMMER PROGRAMS TO ACCOMMODATE CDC GUIDELINES FOR KEEPING CLUB MEMBERS AND STAFF SAFE.
